- Persons in the service of the state are not allowed to bid; Attach certified director/s ID document/s
- Attach Valid Copy of SARS pin number Certificate;
- Proof of registration with National Treasury Central Supplier Database Registration
- Recent Municipal Statement of account (not older than 3 months) for the company and all directors not in arrears for more than 90 days or lease agreement with a recent rental invoice/statement must be attached. Attention is drawn to the "Clearance Certificate for Municipal Account". The Clearance Certificate must be completed by the Municipality where the business resides or the Landlord in case of a tenant.
