1. INTRODUCTION

Proposals are requested from Service Providers who can supply, deliver, install and configure a point-to-point wireless link at WRDM municipal health services Westonaria, a point-to-point fiber cable to link two building at Westonaria fire station and Randfonten fire station.

2. BACKGROUND

Westonaria MHS

The WRDM Westonaria municipal health services office has no internet access and LAN access to the WRDM Head office in Randfontein. The MHS office is located 500m across the Westonaria Library containing a network transmission cabinet, the is complete line of site with no obstructions from the library to the MHS office where the wireless equipment will need to be mounted.

Westonaria Fire station

The Fiber cable must be installed to link the control room where the transmission equipment resides and the admin office block where computing takes place.

Randfontein Fire station

The Fiber cable must be installed to link the control room where the transmission equipment resides and the admin office block where computing takes place.
