Terms and Conditions relating to tendering:

- The West District Municipality's Supply Chain Management Policy and Preferential Procurement Policy shall apply;
- Bids must only be submitted on the bid documentation (MBD1, Ethics Commitment Form, 4, 6.1,8 and 9) provided by the West Rand District Municipality.
- Please make use of table 1 in MBD 6.1 to claim points for specific goals. Non completion thereof will be interpreted to mean that specific points are not claimed.
- Points claimed on disability must be substantiated through the submission of relevant medical documentation issued by a
 qualified medical practitioner.
- The municipality reserves the right to require of a bidder, either before a quotation is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the municipality.
- The lowest or any quote will not necessarily be accepted and the Municipality reserves the right to accept where applicable a portion of any quotation;

DESCRIPTION: SUPPLY AND DELIVERY OF WILDERNESS RESCUE SET FOR FIRE AND RESCUE SERVICES.

SCOPE OF WORK:

The RFQ aims to procure a wilderness rescue set, a vital asset for our Fire and Rescue Services to efficiently and safely perform wilderness and remote-area rescue operations. The wilderness rescue set should include the following equipment and meet specific technical requirements:

- 1. 4 x Pick-off straps.
- 2. 2 x Pulley double large.
- 3. 2 x Pulley single large.
- 4. 2 x Petzel maestro's.
- 5. 1 x Petzel twin release with 100m x 11mm rope and 1 x Petzle spin L2 black.
- 6. 4 x Anchor straps (2m lengths).
- 7. 40 x Petzle OK Triact-lock carabiner's.
- 8. 4 x Kernmantle rope 11mm x 50m.

1.2 Applicable Preference Point System

- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
