Specifications, and bidding documents must be obtained at the West Rand District Municipality and WRDM Website and be returned in a sealed envelope clearly marked with the **bid number**, **description** and **closing date**. Deposit it in the RFQ Box situated at the Entrance of Supply Chain Department (**Inside the building**), Municipal Building, Corner Park & 6th Str. Randfontein.

Terms and Conditions relating to tendering:

- The West District Municipality's Supply Chain Management Policy and Preferential Procurement Policy shall apply;
- Bids must only be submitted on the bid documentation (MBD1, Ethics Commitment Form, 4, 6.1,8 and 9) provided by the West Rand District Municipality.
- The bids will be evaluated and adjudicated in terms of Preferential Procurement Policy Framework, Act No.5 of 2000, Preferential Procurement Regulations 2022, West Rand District Municipality Preferential Procurement Policy and Supply Chain Management Policy of the West Rand District Municipality.

- Points claimed on disability must be substantiated through the submission of relevant medical documentation issued by a qualified medical practitioner.

Exempted Micro-Enterprises (EMEs) and Qualifying Small Enterprises (QSEs) must attach sworn affidavit declaring the BBEE status.
- The municipality reserves the right to require of a bidder, either before a quotation is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the municipality.
- The lowest or any quote will not necessarily be accepted and the Municipality reserves the right to accept where applicable a portion of any quotation;

TERMS OF REFERENCE/ SPECIFICATIONS

FULL ASSESSMENT AND REDESIGN OF AN EXISTING SPRINKLER SYSTEM, REPAIR, SERVICING AND MAINTENANCE OF THE SPRINKLER SYSTEM: WR/CORP/09/2026.

1. PURPOSE:

The purpose of this bid is to appoint an accredited service provider to conduct a full assessment and redesign of the existing sprinkler system, repair, service, and maintenance of the system installed in the municipal building.

2. BACKGROUND:

- The safety and well-being of personnel, assets, and infrastructure remain a top priority within our organization. In alignment with occupational health and safety regulations, as well as internal risk management protocols, it is essential to ensure that all fire protection equipment remains fully functional, compliant, and readily available for emergency use.
- As part of ongoing safety and compliance measures, the municipality seeks to procure professional services of an accredited and experienced fire safety service provider to conduct repairs, complete service and maintenance of the sprinkler system which include: -
 - Conduct an urgent full assessment and redesign of the existing sprinkler system
 - Inspect, repair, and service the sprinkler system
 - Reset and restore the system to operational status, and
 - Conduct a full maintenance check and provide Certification of Compliance (COC).
- The service provider must be properly accredited and compliant with the relevant fire protection and safety standards.
- The Occupational Health and Safety Act and any other relevant legislation must be complied within the proposal to make the WRDM building complaint with regard to fire prevention.

3. SCOPE OF WORK:

The service provider shall carry out the following activities:

3.1 Full assessment and redesign of the existing sprinkler system:

- Carry out a full assessment and redesign of the existing sprinkler system in accordance with the requirements of relevant fire standards, e.g. **SANS 10287**.
- Determine and ensure the correct system design parameters, hazard classification, and water supply requirements, including pump capacity and tank sizing.

3.2 Inspection and Assessment:

- Conduct a full inspection of the sprinkler system, including all pipes, valves, sprinkler heads, alarm valves, pressure gauges, control valves, and pumps.
- Assess the condition of all components and identify faults, leaks, corrosion, or blockages.
- Check the water supply, pressure, and flow conditions.
- Verify that the system layout matches the approved design drawings and complies with fire safety standards.
- Inspect fire pumps, jockey pumps, and control panels for operational readiness.

3.3 Repairs:

- Replace or repair any defective or damaged components, including sprinkler heads, pipe fittings, valves, gauges, and seals.
- Repair leaks or damaged pipework resulting from corrosion or mechanical impact.
- Reset the system after activation and ensure all control valves are correctly positioned.
- Ensure the sprinkler alarm system and water motor gong (if applicable) are fully operational.
- Restore water supply to the sprinkler system and verify there are no further leaks.

3.4 Servicing and Testing:

- Clean and test all sprinkler heads for blockage or obstruction.
- Test alarm valves, control valves, and flow switches for correct operation.
- Test the fire pump(s) and record suction and discharge pressures.
- Test the water motor alarm and electronic alarm transmission system.
- Check the functionality of pressure maintenance devices (jockey pump).
- Simulate system operation to confirm correct activation sequence.
- Drain and flush system where necessary to remove sediment or debris.

3.5 Maintenance:

- Conduct proper maintenance of the system, and also lubricate all parts as required.
- Inspect and test the system quarterly, semi-annually, and annually in accordance with relevant legislation.
- Maintain accurate records of inspections, tests, and repairs.
- Provide recommendations for system improvements, upgrades, or replacements.

4. RECOMMENDATIONS:

- It is strongly recommended that the sprinkler system be urgently serviced to ensure reliability, regulatory compliance, and optimal performance in the event of a fire.
- The sprinkler system is an essential fire safety mechanism required under occupational health and safety and fire safety regulations.
- After activation during the recent fire incident, the system must be professionally reset, inspected, and tested to ensure it is fully functional.
- Continued disconnection of the system poses a significant fire risk to the municipal building and its occupants.
- Engaging an accredited service provider will ensure compliance with relevant safety standards.
- Proactive maintenance will prevent similar incidents and protect municipal assets and personnel.

5. COMPULSORY REQUIREMENTS:

- The service provider must provide a proof of **accreditation on fire protection** registered with an approved body such as **ASIB (Automatic Sprinkler Inspection Bureau)** or equivalent.
- Proof of accreditation, insurance, and safety compliance must be provided before commencement of work.
- The service provider shall provide a **12-month warranty** on all parts and workmanship.
- The system must operate correctly after completion of repairs and service.
- Provide a **detailed condition report** after inspection and testing.
- Submit a **certificate of compliance (COC)** confirming compliance with fire safety standards.
- The service provider must adhere to the provisions of the Occupational Health and Safety Act, 1993 at all times.

NB: Failure to adhere to the above mentioned requirements will result the bid being non-responsive.
