1. PURPOSE:

The purpose of this bid is to appoint accredited service provider for the refurbishment of the Executive Mayor's official house located at 31 Aloe Street, Greenhills in order to restore the property to an acceptable standard, and further ensuring compliance with health and safety requirements, and preserve the municipality's asset value.

The property is a meaningful asset that has experienced deterioration due to normal wear and tear and limited recent maintenance. A technical assessment has identified required refurbishment works to ensure property meets safety standards and is suitable for occupation.
