Purpose

The WRDM seeks to source services from reputable service providers for the repair of the HP DesignJet T2300 Plotter located at the GIS office.

Introduction

The GIS plotter printer is utilized for printing and scanning of maps in various sizes in support of departments within the WRDM and the public.

Reputable service providers are invited to bid for the repair of the GIS plotter and to ensure that it is fully operational.

Scope of work

1. Full diagnosis of the Printer
2. Repair x1 HP DesignJet T2300 Plotter
3. Replacement of all defective components including consumables

Mandatory

Bidders are required to perform a compulsory site inspection of the printer in order to price accurately. Bidders must offer a minimum of 3-month warranty on parts and workmanship. Contact KTsoane@wrmd.gov.za for site inspection arrangements.

The quotation must include parts to be replaced if any.
