Reputable service providers are invited to bid for the repair of the GIS plotter and to ensure that it is fully operational.

3. Scope of work

- 1. Full diagnosis of the Printer
- 2. Repair x1 HP DesignJet T2300 Plotter
- 3. Replacement of all defective components including consumables

4. Mandatory

Compulsory site inspection of the printer for first time bidders.
