The unit shall be mounted onto a 1 ton LDV without the need for any special equipment.

The mechanical system shall mount to a steel base of 5 mm thick. Double V Belts & pulleys are used to couple the Engine to the Pump.

A safety off loader valve shall be fitted to provide regulation of the system operating pressure and pressure relief. A Pressure Gauge is fitted to the Pump.



- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
