<b>DESCRIPTION OF SERVICES</b>	<b><u>TERMS OF REFERENCE</u></b>  <b><u>1. BACKGROUND</u></b>  In terms of section 17 of the regulations, it is the responsibility of the municipality to assist the employees in attaining the required level of competency through the provision of resources or opportunities. The MFMP is designed around requirements of the competency regulations as stipulated in the Government Gazette and it is compulsory for all employees who handles Municipality funds.

## **2. SCOPE OF WORK**

1. The successful training service provider will be expected to conduct training for seven (7) employees of West Rand District Municipality (where they would be required to apply their acquired skill and knowledge after the training)
2. The development and design of the MFMP in order to ensure that participants are able to learn and apply skills acquired and to accumulate credits towards full certification.
3. The training service provider would be expected to deliver training on all the specific outcomes and assessment as per the registered learning programme.

## **3. EXPECTED DELIVERABLES**

- The purpose of the comparison is to ensure a meaningful evaluation; bidders are requested to furnish detailed information of substantiation of compliance to the evaluation criteria. The service provider should at least score the minimum of minimum of 50% points in order to be considered to the next evaluation phase.
